## INTRODUCTION

- 1. The purpose of Amendment Number 2 to the JSF IOT&E MOU is to remove references to the Ministry of Defence of the Republic of Italy, which declined to be a Participant in the MOU.
- 2. Accordingly, the State Secretary of Defence of the Kingdom of the Netherlands, the Secretary of State for Defence of the United Kingdom of Great Britain and Northern Ireland, and the Secretary of Defense on behalf of the Department of Defense of the United States of America have reached the following understandings:

# AMENDMENT

The JSF IOT&E MOU is hereby amended as follows:

# 1. TITLE PAGE:

a. Replace the current Title Page with the following Title Page:

# 2. INTRODUCTION:

- a. The opening paragraph is revised to read as follows: "The State Secretary of Defense of the Kingdom of the Netherlands (NL MOD), the Secretary of State for Defence of the United Kingdom of Great Britain and Northern Ireland (U.K. MOD), and the Secretary of Defense on behalf of the Department of Defense of the United States of America (U.S. DoD), hereinafter referred to as the "Participants":".
- b. In the last sentence of the fifth paragraph, delete: "the U.S. DoD-IT MOD Supplement,".
- 3. SECTION II (OBJECTIVES):

Paragraph 2.1. is revised to remove ""IT MOD and".

4. SECTION IV (MANAGEMENT (ORGANIZATION AND RESPONSIBILITY)):

Paragraph 4.4. is revised to remove "one delegate from the IT MOD," in the first sentence, and the fifth sentence is deleted and substituted with the following: "The NL MOD delegate will be identified by the NL Participant and will serve in a non-voting capacity.".

- 5. SECTION V (FINANCIAL PROVISIONS):
- a. Paragraph 5.1. is revised as follows: delete in the first sentence "455.67" and substitute "425.67".
- b. Delete subparagraph 5.2.3. and renumber the subsequent subparagraph as subparagraph 5.2.3.
  - c. Paragraph 5.3. is revised to delete ",IT MOD,".

## ENTRY INTO EFFECT

This Amendment Number 2 to the JSF IOT&E MOU will enter into effect upon signature below by all the Participants. This Amendment will remain in effect for the same period as the MOU that it amends, and will expire upon termination or expiration of that MOU. Unless specifically amended herein, all other provisions of the JSF IOT&E MOU remain unchanged.
