On January 28<sup>th</sup> and 29<sup>th</sup>, 2010, an Interparliamentary Conference was held in The Hague on the issue of improving national accountability of EU funds. The conference was attended by Parliamentarians from 20 Member States and by observers from several institutions, such as the European Parliament, the European Commission and various Courts of Auditors. Keynote Speakers were Mr. L. De Magistris, Chair of the Budget Control Committee of the European Parliament, Mr. J. Bonnici, Member of the European Court of Auditors, Mr. G. De Vries, Member of the Netherlands Supreme Court of Audit, and Mr. F. De Nerée tot Babberich, Member of the House of Representatives of The Netherlands.

The Conference adopted a Conference Statement. It is our pleasure to bring this Statement to your attention, in your quality as Chair of COSAC. We kindly ask you to distribute this Statement among the Members of COSAC.

Accountability of EU budgetary funds is closely linked to the general issue of EU budget reform and is directly related to the European Commission proposal on the EU Financial Regulation, scheduled for Spring 2010. We also refer to the last Plenary Meeting of COSAC, held on 5-6 October 2009 in Stockholm, which selected “the reform of the EU budget and its financing mechanism” as one of the topics to be dealt with in 2010. We recommend that this Conference Statement is used as input to COSAC’s deliberations on this issue.


