**Subject: Corrigendum to Commission decision C (2009) 9963 final of 15 December 2009 – No E 2/2005 and N 642/2009 – The Netherlands**

Sir,

**1. PROCEDURE**

By decision C (2009) 9963 of 15 December 2009 (hereinafter "the decision"), the Commission decided that State aid granted to housing corporations was compatible with the internal market.

**2. DESCRIPTION OF ERRORS**

It has been discovered that the decision contains one mistake. In the part IV.1, describing the special project aid, paragraph 80, instead of "EUR 250 million" it should be "EUR 750 million".

**3. FINAL REMARKS**

For the sake of legal certainty it has been decided to adopt a corrigendum of the decision. In the above mentioned part of the decision the incorrect word has been replaced by the correct one.

The above corrections do not modify the operative part of the decision and therefore do not modify the conclusion regarding the compatibility of the aid with the internal market.
