Frans L Leeuw (sociologist) was born in 1953.

He was President of the European Evaluation Society (1999-2002). As of September 2003, he is President of the Dutch Evaluation Society. He is currently a *Professor of Law, Public Policy and Social Science Research*, University of Maastricht. He also is *the Director of the Ministry of Justice Research Center (WODC)*, Den Haag, the Netherlands.
