Dear Mr Townend,

I recently contacted you to ask if you would be willing to give us the benefit of your expertise by providing an independent opinion of a report published in the Netherlands regarding nature restoration in the Western Scheldt estuary. I am delighted at your positive response to my request on behalf of the Dutch State Secretary of Economic Affairs, Agriculture and Innovation, and that you are willing to give your independent judgement of the above-mentioned report.

I am writing to provide you with the following additional information. As I already informed you, a debate is currently taking place in the Netherlands regarding measures for nature restoration in the Western Scheldt estuary. The Netherlands has an important role in the task of maintaining the current ecological value of the estuary of the Western Scheldt. In June 2011, the Dutch parliament voted in favour of a package of governmental measures designed to promote nature restoration in the Western Scheldt. This package of measures focuses particularly on taking steps outside the dikes, i.e. in the estuary itself, due to the social sensitivity of the decision to flood polders in particular areas in order to create more space within the estuary.

The package of measures proposed by the Dutch government regarding nature restoration in the Western Scheldt is based on scientific recommendations made by Deltares, a Dutchinstitute for applied research and development. The European Commission recently asked questions about the Dutch approach to nature restoration in the Western Scheldt. Some of those comments are related to the extent to which the Netherlands has scientifically underpinned its measures. The Dutch government takes the stance that it has adequately underpinned its proposals. Nevertheless, the State Secretary wants to ascertain once more that the approach he has chosen is founded on sufficient and up-to-date scientific insights.
