Next week on the 24th in the Netherlands there are 'herindelingsverkiezingen', elections for a couple of municipalities that have fused into one new municipality.

We received a message from one of these municipalities, that when both the municipality and citizens want to share the link the municipality has posted to a website that helps determine which political party matches your preference most (an objective voting advice tool), their shared post is immediately deleted/not visible to others.

This specific example was about this link: <https://dijkenwaard.kieskompas.nl> , it was supposedly also this FB message that people couldn't share which has the link in it: https://fb.watch/9ma_TNNXVi/

See the picture attached I received from the municipality employee. It said "nobody else can see your message".

Apparently, currently the message is no longer automatically deleted. But I wanted to flag this and ask if you know why this message was being deleted?

We received a notification from a local politician in the municipality Beek that his personal Instagram page (**Persoonsgegevens**) and the Instagram page of the local political party (@cda.beek) are blocked.

According to the political party, no reason for this block was given. Hence the party has the suspicion that a group of people purposely made false reports to get these accounts deactivated.

Could you maybe look into this block? The local elections are next week, and the party is using these accounts also for campaigning purposes.
