Dear Mr ,

Yesterday there were several (attempted and presumed) instances of arson at mobile antenna sites used for 4G/5G mobile cell service in the municipalities of Beesd and Deurne in the Netherlands. One of these sites was tagged with 'f*uck 5G' graffiti. We are concerned that more (attempted) arsons may follow, possibly impacting the regional availability of the 1-1-2 emergency services number, C2000 critical communications or the NL-Alert public information system.

We are reliably informed of an uptick in interest to 5G-related radiation sites and groups, as well as an uptick in visits coming from 5G-related Twitter accounts to sites listing locations of telecom infrastructure. I would like to discuss with you the options for submitting accounts that possibly violate the Twitter terms of use to you for review. Please feel free to contact me using the details below.
